Cancellation after this confirmation will be considered as due.

For any cancellation:

In case of cancellation by the customer between:

42 and 15 days before the date of the meal(s), deposit(s) paid will be retained by the hotelier restaurateur.

At least 15 days to 72 hours before the group's arrival, 75% of the value of the services will be billed to the customer (deduction made from the advance payments if any).

In case of cancellation within 72 hours of arrival, the services will be charged 100%.

In the event of a partial cancellation, the above amounts will be kept or charged in proportion to the number of people canceled.

Equipment and the Restaurant Dining Room:

Any Important damage will be on the customer.

(We will carefully determine the importance of the damages)

Regulations :

Payment is made no later than the end of the meal or the stay in a single, payment, deductions made on advance payments.

In case of non payment or returned checks for insufficient funds or bank account, The Relais du Parisis reserves the right to recover its due, through a debt collecting company of its choice;

Recoveries will be charged as per the value of the outstanding balance, increased by a minimum of 20% depending on the amount in dispute and an injunction proceeding for payment will eventually be engaged, before the competent courts.
